### an assistant professor in a group of research and teaching staff in the field of mathematics

for the period from 01/10/2020 to 30/09/2022 with the possibility of extension to a permanent position

# I) Conditions of the competition:

The competition is open to persons who meet the conditions specified in the Act on Higher Education and Science of 20 July 2018 as amended (Journal of Laws 2018, item 1668.) and meet the following eligibility criteria:

- 1) PhD.
- 2) Scientific achievements, in the last 3 years, documented by publications in journals indexed in Journal Citation Reports and included in the ministerial list of scientific journals in the field of mathematics.
- 3) Fluency in English.
- 4) At least two years of work experience after obtaining the PhD.
- 5) Experience in conducting teaching classes and participation in research projects resolved in competitions.

## **II)** Required documents:

- 1) An application addressed to the Rector.
- 2) Scientific resume and a list of published papers.
- 3) A copy of PhD diploma.
- 4) Declaration of knowledge of English or Polish to the extent that allows teaching classes with students.
- 5) Statement on meeting the statutory conditions and that in the case of employment the University of Bialystok will be the candidate's primary place of work within the meaning of the abovementioned Act (appropriate forms are available at <a href="http://math.uwb.edu.pl/~zaf/calls">http://math.uwb.edu.pl/~zaf/calls</a>).
- 6) The candidate's declaration of consent to the processing of personal data, in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repeal Directive 95/46 / EC (General Data Protection Regulation / GDPR).
